Sealed proposals will be received by the Village of Arcanum (Owner) on behalf of themselves and the Darke County Board of Commissioners (Contracting Authority) at the Arcanum Municipal Building 104 West South Street, Arcanum, Ohio 45304 until **1:00 p.m. (local time) on Thursday, November 21, 2013** for furnishing all labor, materials, and equipment necessary to complete the project known as the **Arcanum South Main Street Reconstruction** project. The bids will then be publicly opened and read aloud.

The work for which proposals are invited consists of approximately 2,600 L.F. of street reconstruction including curb and sidewalk; 1,900 L.F. of 8" through 18" storm sewer; 2,900 L.F. of 8" through 10" water line; and all appurtenances related to the completion of the project. The Owner intends and requires substantial project completion no later than **August 15, 2014**.

Contract Documents including specifications and the plans may be examined at the office of the Village of Arcanum, 104 West South Street, Arcanum, Ohio 45304 or obtained at the office of the Consulting Engineer, Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331. A non-refundable charge for each set of the Plans and Contract Documents will be required in the amount of \$145.00. **Proposals will only be accepted from bidders who have obtained Contract Documents (including plans and specifications) from Mote & Associates, Inc. and have been registered as a planholder.**

A Pre-Bid Conference will be held on Wednesday, November 13, 2013 at 10:00 AM at the Village of Arcanum Municipal Building located at 104 West South Street, Arcanum, Ohio. All Bidders are encouraged to attend since written comments will only be distributed as an Addendum, if deemed necessary by the Engineer.

Each bidder is required to furnish with its proposal a 100% Bid Guaranty and Contract Bond or a certified check, or a cashier's check upon a solvent bank in the amount of 10% of the bid in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity.

Additionally, attention of bidders is called to all of the requirements contained in the Contract Documents and on the plans, particularly to the Federal Labor Standards Provisions including the Davis-Bacon Prevailing Wage Rates, various insurance requirements, various equal opportunity provisions, and the requirement for a 100% Performance and Payment Bond. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

The Darke County Board of Commissioners and the Village of Arcanum reserve the right to accept or reject any or all bids, to waive any informalities in the bidding, and to enter into a contract with the bidder who, in their consideration, offered the lowest and best bid.
