MAIN STREET RECONSTRUCTION PHASE I**

**ADVERTISEMENT FOR BIDS**

Sealed bids will be received by the Village of Verona, Ohio at the Village Office located at 138 Mill Street, P.O. Box 676, Verona, Ohio, 45378 until **1:00 P.M. (local time), on Thursday, July 13, 2017** for furnishing all labor, materials, and equipment necessary to complete the project known as **Main Street Reconstruction Phase I**. The bids received will then be publicly opened and read aloud. The work for which proposals are invited consists of storm drainage and curb installation as well as full-depth reclamation of the roadway from the west corporation to Harrison Street.

The Contract Documents including Specifications may be examined or obtained from the Issuing Office of the Consulting Engineer, Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331 (937.548.7511). A non-refundable charge for the Contract Documents will be required in the amount of \$75.00 per set, payable to Mote & Associates, Inc. A non-refundable handling charge of \$15.00 will be required if documents are to be shipped. An electronic version is also available for a non-refundable charge of \$25.00. The Owner and/or Engineer will not be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Engineer. **Proposals will only be accepted from bidders who have purchased the Contract Documents from Mote & Associates, Inc. and are registered as a planholder.** A Pre-Bid Meeting will be held on Thursday, July 6, 2017 at 10:00 AM at the Village Office.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experiences on the projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that the project be completed on or before **November 15, 2017** or an Alternate Date of **August 1, 2018**. No Bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

Additionally, attention of bidders is called to all of the requirements contained in the Contract Documents and on the plans, particularly to the Federal Labor Standards Provisions, various insurance requirements, various equal opportunity provisions, and the requirement for a 100% Performance and Payment Bond.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required.

DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 OF THE REVISED CODE CAN BE OBTAINED FROM THE OFFICE OF THE OHIO FACILITIES CONSTRUCTION COMMISSION. Steel products is defined in Revised Code Section 153.011 as: "...products rolled, formed, shaped, drawn, extruded, forge, cast, fabricated or otherwise similarly processed.....and used for load-bearing structural purposes...."

The Village of Verona reserves the right to accept or reject any or all proposals, to waive any informalities in the bidding, and to enter into a contract with the bidder whom in their consideration offered the lowest and best proposal.
