(local time), on Tuesday, December 19, 2017,** for furnishing all labor, materials, and equipment necessary to complete the project known as **Eastmoor Drive and Front Street Reconstruction.** The bids will then be publicly opened and read aloud. The work for which proposals are invited consists of approximately 2,000 L.F. of street reconstruction including replacement of sidewalk, curb and gutter along with installation of sanitary and storm sewer, water lines, and all related appurtenances. An Alternate Bid to extend the reconstruction an additional 570 L.F. is also offered.

Proposals will only be accepted from bidders who have purchased the Contract Documents from Mote & Associates, Inc. and are registered as a planholder.

A Pre-Bid Meeting will be held at the Village Office located at 214 North Washington Street, New Bremen, on <u>Monday</u>, <u>December 11, 2017, at 3:00 P.M.</u> Representatives of the engineer will be present to answer questions and the project site available for inspection. This meeting is not mandatory but highly encouraged.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experiences on the projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that the project be completed no later than <u>October 12, 2018</u>. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required.

Bidders must comply with the prevailing wage rates on Public Improvements in Auglaize County as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration.
