ADVERTISEMENT FOR BIDS

Sealed Bids will be received for the construction of a new Mechanical Wastewater Treatment Facility by the Village of Arcanum at the Municipal Office located at 104 West South Street, Arcanum, Ohio 45304, **until 1:00 PM local time on Wednesday, March 22, 2017.** At this time the Bids received will be publicly opened and read aloud. The Project consists of the following contracts: A) Construction of a new 400,000 gallon per day mechanical wastewater treatment facility; B) Reconstruction of an existing wastewater lagoon for partial use as an equalization basin; and/or C) Modification to an existing wastewater lagoon for use as an equalization basin.

Prospective Bidders may examine or obtain the Bidding Documents at the Issuing Office Monday through Friday between the hours of 8– 12 AM and 1 -5 PM. Printed copies will be provided upon payment of a non-refundable deposit of \$300.00 for each set, with an additional mailing charge of \$30.00 if shipped. Bidding Documents are also available via electronic files for a non-refundable deposit of \$25.00. Checks shall be payable to “Mote & Associates, Inc.” Bidding Documents also may be examined at the Arcanum Municipal Building, 104 West South Street, Arcanum, Ohio or McGraw Hill Construction Plan Room, 3077 Kettering Boulevard, Dayton, Ohio 45439. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. **Proposals will only be accepted from bidders who have purchased Contract Documents and Plans from Mote & Associates, Inc. and are registered as a planholder.**

A pre-bid conference will be held at the Arcanum Municipal Office at 104 West South Street, Arcanum, Ohio at **1:00 PM local time on Wednesday, March 8, 2017.** Attendance is highly encouraged, but is not mandatory.

Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each Bidder must submit evidence of its experience on projects of similar size and complexity along with a list of all subcontractors to be used. The Owner intends and requires that Contract ‘A’ be completed by December 31, 2018; Contract ‘B’ by December 31, 2019; and/or Contract C by August 31, 2019. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

Additionally, attention of bidders is called to all of the requirements contained in the Contract Documents and on the plans, particularly to the Federal Labor Standards Provisions including the Davis-Bacon Prevailing Wage Rates, various insurance requirements, various equal opportunity provisions, and the requirement for a 100% Performance and Payment Bond. All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required.

DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 OF THE REVISED CODE CAN BE OBTAINED FROM THE OFFICE OF THE OHIO FACILITIES CONSTRUCTION COMMISSION. Steel products is defined in Revised Code Section 153.011 as: “...products rolled, formed, shaped, drawn, extruded, forge, cast, fabricated or otherwise similarly processed.....and used for load-bearing structural purposes....”
