This Addendum forms a part of the Contract Documents and modifies the original Contract Documents dated August 2019. Acknowledge receipt of this Addendum in the space provided on the Bid Proposal form. Failure to do so may subject the Bidder to disqualification.

CHANGES/CLARIFICATIONS TO THE BIDDING DOCUMENTS:

1. Section 00 75 49, Federal Requirements

- For clarification purposes, this project is being funded in part with federal Community
 Development Block Grant (CDBG) monies as well as local funds. These federal funds invoke the
 Davis-Bacon Wages as well as other requirements contained in this section. The only
 Certifications that are required to be submitted to the County are those contained within the
 Contact Documents Manual and listed in the Table of Contents.
- 2. Within the section entitled "Special Equal Opportunity Provisions", item B., 2. Regarding the Notice of Requirement for Affirmative Action to Ensure Equal Employment Opportunity, note the following:
 - a) This section only applies to subcontracts that exceed \$10,000.
 - b) This section provides "goals" for participation of subcontracts owned by minorities and females or the employment of minorities and female workers in the construction project. A good faith effort to meet these goals could consist of soliciting quotes from minority or female owned subcontractors. There is no requirement to utilize these subcontractors should they not provide quotes or if their quotes are in excess of other quotes received for the same trade(s) from companies that are not minority or female owned.
- 3. Within the section entitled "Special Equal Opportunity Provisions", item B., 2. (d), the "covered area" has been revised to read the State of Ohio, Darke County.

CHANGES/CLARIFICATIONS TO THE TECHNICAL SPECIFICATIONS:

2. Section 01 23 00, Alternates

The drawing located at the end of this section that references Alternate Bid #3, does not intend for the Contractor to provide a trench foundation for the folding door system. The foundation work will

include floor removal and placement of three (3) footings for three (3) columns as shown.

3. Section 01 45 23, Testing and Inspection Services

For clarification purposes, in regards to concrete test samples, one (1) set of test samples will be required for base bid concrete and one (1) additional set will be required if Alternate Bid #1 is accepted.

A summary of test requirements includes:

- 1) Concrete testing as described above.
- 2) Compacting testing if Alternate #1 is accepted.
- 3) Testing balancing and adjusting where required by respective equipment, including existing and proposed HVAC systems.
- 4) Inspections and testing where required by laws, ordinances, rules, regulations or orders by public authorities or general conditions.
- 5) Field welding is not anticipated for the project.
- 6) Water system testing as required by public authorities.
- 7) Plumbing testing as required for plumbing inspectors.
- 8) All other testing as specified in the Contract Documents.

CHANGES/CLARIFICATIONS TO THE CONSTRUCTION PLANS:

4. Sheet A1.02, Floor Plan

It is the intent that the proposed store front door styles match the existing set of entry doors at the main entry on the east opening of existing foyer 103A.

5. Sheet A6.01, Schedules

- 1. Remarks B & C: Delete reference to Kawneer 425 Thermal Entrance Series doors. Door #9 and #10 are to be Kawneer 350 medium style with 1" insulated glass.
- 2. Door #1 and #10 are the only proposed doors required to have automatic ADA operators.
- 3. Door #1 is the only door required to have a key fob.

 - Alternate Bid #3 Folding Partition Wall Drawing: Is there a trench required across the length of the floor?
 - Answer: No, only 3 footings and 3 columns are to be installed (there is no trench foundation at the location).
 - Who is responsible for the WIFI hub in the wall being removed?
 Answer: The Owners have WIFI set up and will be responsible for all IT work not specified in the drawings.
