Sealed bids will be received by the Jefferson Township Trustees, Preble County, Ohio at the Township Office located at 9430 Smyrna Road, New Paris, Ohio until **7:00 P.M. (local time), on Monday, January 13, 2020** for furnishing all labor, materials, and equipment necessary to complete the project known as **Hollansburg Road Improvements**. Sealed bids shall also be accepted by the Issuing Office of the Consulting Engineer, Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio, until 5:00 P.M. on Monday, January 13, 2020. Mote & Associates, Inc. shall deliver any sealed bids received to the Township Office where the bids will then be publicly opened and read aloud at 7:00 PM. The work for which proposals are invited consists of replacement of a box culvert with new driving surface along with overlay and berming of Hollansburg Road from New Paris-Hillsboro Road east to Primrose Road.

The Contract Documents including Specifications may be examined or obtained from the Issuing Office of the Consulting Engineer, Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331 (937.548.7511). A non-refundable charge for the Contract Documents will be required in the amount of **\$50.00** per set, payable to Mote & Associates, Inc. An additional non-refundable handling charge of **\$15.00** will be required if documents are to be shipped. An electronic version of the Contract Documents is also available for a non-refundable charge of **\$25.00**. The Owner and/or Engineer will not be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Engineer. **Proposals will only be accepted from bidders who have purchased the Contract Documents from Mote & Associates, Inc. and are registered as a planholder.**

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that the project be completed no later than **July 31, 2020**. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required.

Bidders must comply with the prevailing wage rates on Public Improvements in Preble County and Jefferson Township as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614-644-2239.
