(local time) on June 15, 2021</u> for furnishing all labor, materials, and equipment necessary to complete the project known as <u>Sanitary Collection System Rehabilitation - Phase I.</u> The bids will then be publicly opened and read aloud. The work will be completed in two contracts or a combination contract as follows: Contract A – Sanitary sewer cleaning, televising, and CIPP liner in 10,283 L.F. of 8" to 12" pipe with manhole rehabilitation; and Contract B – Replacement of 1,012 L.F. of 8"-10" sanitary sewer with manholes. Contract C will be a combination of all work from both Contracts A and B.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experiences on the projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that the project be completed no later than **April 30, 2022 for Contract 'A' Sanitary Sewer Relining and November 30, 2021 for Contract 'B' Sanitary Sewer Replacement. If Contract C is awarded, all work shall be completed by April 30, 2022.** No bidder may withdraw his bid within ninety (90) days after the actual date of the opening thereof.
