At this time the Bids received will be publicly opened and read aloud. The Project consists of contracts for installation of gravity and force main sewers including two lift stations and the construction of a wastewater treatment facility with all to be fully operational.

Bidding Documents are available via electronic files for a non-refundable deposit of \$25.00. Prospective Bidders may also examine or obtain the Bidding Documents at the Issuing Office during normal business hours. Printed copies will be provided upon payment of a non-refundable deposit of \$300.00 for each set, with an additional shipping charge of \$30.00 if applicable. All checks shall be payable to "Mote & Associates, Inc.". Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. Proposals will only be accepted from bidders who have purchased Contract Documents and Plans from Mote & Associates, Inc. and are registered as a planholder.

A pre-bid conference will be held at the Palestine Community Building located at 105 North Main Street, Palestine, Ohio, 45352 at 1:00 PM local time on Tuesday, July 20, 2021. Attendance at the pre-bid conference is highly encouraged, but is not mandatory.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experiences on the projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that Substantial Completion of the project be completed no later than May 31, 2023 for Contract A and no later than July 31, 2023 for Contract B. No bidder may withdraw his bid within ninety (90) days after the actual date of the opening thereof.

Additionally, attention of Bidders is called to the requirements contained in the Contract Documents and on the plans, particularly to the Federal Labor Standards Provisions including the Davis-Bacon Prevailing Wage Rates, various insurance requirements, and various equal opportunity provisions. All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required. This procurement is subject to the EPA policy of encouraging the participation of small business in rural areas (SBRAs).
