Sealed bids will be received on behalf of the Village of Gratis, Ohio (Owner) at the Village Office located at 404 Harrison Street, P.O. Box 574, Gratis, Ohio 45330 until **2:00 P.M. (local time), on June 7, 2023** for furnishing all labor, materials, and equipment necessary to complete the project known as **Village of Gratis – Ada Doty Storm Outlet**. The bids will then be publicly opened and read aloud during the regular session on the same day. The work for which proposals are invited consists of approximately 1050' of water and storm line replacement.

The Contract Documents including Specifications may be examined or obtained from the Issuing Office of the Consulting Engineer, Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331 (937.548.7511). A non-refundable charge for the Contract Documents is required in the amount of \$45.00 per set, payable to Mote & Associates, Inc. An additional non-refundable handling charge of \$15.00 will be required if documents are to be shipped. An electronic version of the Contract Documents is also available for a non-refundable charge of \$25.00. The Owner and/or Engineer will not be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Engineer. **Proposals will only be accepted from bidders who have purchased the Contract Documents from Mote & Associates, Inc. and are registered as a planholder.**

Each Bidder is required to furnish with its proposal a Bid Bond or certified check in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each Bidder must submit evidence of its experience on projects of similar size and complexity, and a complete list of all subcontractors to be used. The Owner intends and requires that the project be substantially complete no later than December 1, 2023. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

Bidders must comply with the prevailing wage rates on Public Improvements in Preble County as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614-644-2239.
