Sealed bids will be received by Neave Township (Owner), at the Office of the consulting engineer, Mote & Associates, located at 214 West Fourth Street, Greenville, Ohio 45331 until 2:00 P.M. **(local time) on March 21st 2024** for furnishing all labor, materials, and equipment necessary to complete the project known as **Neave Township - Storage Building**. The bids will then be publicly opened and read aloud. The work for which proposals are invited consists of constructing a 50'X70' wood framed shop 16' to the square with a cast-in-place concrete foundation.

The Contract Documents including Specifications may be examined or obtained from the Issuing Office of the Consulting Engineer, Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331 (937.548.7511). A non-refundable charge for the Contract Documents will be required in the amount of \$75.00, payable to Mote & Associates, Inc. An additional non-refundable handling charge of \$15.00 will be required if documents are to be shipped. An electronic version of the Contract Documents is also available for a non-refundable charge of \$25.00. The Owner and/or Engineer will not be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Engineer. **Proposals will only be accepted from bidders who have purchased the Contract Documents from Mote & Associates, Inc. and are registered as a planholder.**

A Pre-Bid Meeting will be held at the Township House located at 3880 State Route 121, Greenville, Ohio on **Thursday, March 7, 2024 at 2:00 PM**. Representatives of the engineer will be present to answer questions and a meeting at the site for inspection will directly follow. This meeting is not mandatory, but highly encouraged.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experiences on the projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that the project be completed no later than **August 16, 2024**. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

Bidders must comply with the prevailing wage rates on Public Improvements in Darke County as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614-644-2239.
