Sealed bids will be received by the Village of North Hampton, Ohio, at the Village Hall located at 250 West Clark Street, PO Box 457, North Hampton, Ohio 45349 until 10:00A.M. **(local time) on Thursday, August 14, 2025** for furnishing all labor, materials, and equipment necessary to complete the project known as **North Hampton Water Storage Tank Demolition**. The bids will then be publicly opened and read aloud. The work for which proposals are invited consists of the demolition and removal of a 140' tall, 100,000 gallon water tower, the support structure and ancillary piping. The area is to be fully restored to the match the surrounding area.

The Contract Documents including Specifications may be examined or obtained from the Issuing Office of the Consulting Engineer, Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331 (937.548.7511). A non-refundable charge for the Contract Documents will be required in the amount of \$50.00, payable to Mote & Associates, Inc. An additional non-refundable handling charge of \$15.00 will be required if documents are to be shipped. An electronic version of the Contract Documents is also available for a non-refundable charge of \$25.00. The Owner and/or Engineer will not be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Engineer. **Proposals will only be accepted from bidders who have purchased the Contract Documents from Mote & Associates, Inc. and are registered as a planholder.**

A pre-bid meeting will be held July 22nd at 10:00AM at the Village Office located at 250 West Clark Street, North Hampton, Ohio 45349. It is highly recommended each bidder's representation attend this pre-Bid meeting.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experiences on the projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that the project be completed no later than December 31, 2025. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required.

Bidders must comply with the prevailing wage rates on Public Improvements in Clark County as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614-644-2239.
